



## DFW Air Cargo Association Tournament Rules and Information

### Count Guarantee:

- The Golf Club requires total player count 10 days prior to tournament date. Please RSVP accordingly. After the 10 days, the Golf Club can guarantee 5% (additional players) of the tournament total count. Anything over 5% (additional players) will be based on availability only.
- Payment is due 10 days prior to tournament date.
- A list of first and last names must be provided to the Golf Club no later than 2 days prior to the tournament date.

### Registration:

- Registration begins at 11:30 AM.
- Buffet lunch will be provided.
- Golf Carts will be staged in front of Club House. Golf Club Staff will assist with taking the players clubs to their assigned cart.
- Players may bring a few clubs with them to the practice area.

### Sponsors and Advertising Options:

- Gold Sponsorship Banner will be placed at the front of the Club House.
- Hole Sponsors will be assigned prior to tournament. A map of the course and sponsored hole assignments will be provided to the sponsors.
  - Sponsors may bring their own tent and table.
  - Tent and table packages are available by the Golf Club and can be arranged with the Event Manger. (See registration form for sponsorship options.)
- **Hole sponsors may begin setting up at their sponsored hole at 1:00 PM. There will be 5 golf carts available for sponsors to take items to sponsored hole. Once setup is complete, the sponsor must return the golf cart to the club house so additional sponsors may setup at their hole. Volunteers will be available if needed and can assist in transporting the sponsors back to their hole prior to shotgun start.**

### Alcoholic Beverage Policy and Options

*\*\*Please note, that **ALL** alcoholic beverages served on the premises must be provided by the Golf Club and dispensed by Golf Club Staff and enforced by the TABC.\*\**

- **Drink Tickets** – Individuals/Companies can establish a certain number of drink tickets with the Golf Club to distribute and use as they wish. The Golf Club staff will keep track of the tickets redeemed, and will only charge the amount based on consumption.

- **Individual Pay** – Individuals are responsible for any alcoholic beverage purchases during event.
  - Prior to Shot Gun Start, individuals may purchase drinks at the bar for their cart coolers.
- **Bar Option** – Hole Sponsors can arrange to have a bar and bartender at their sponsored hole for \$150 + 21% service charge + tax.
- **Drink Carts** will be making their way around the course throughout the tournament.

**Golf Club Cancellation Policy**

Client shall have the right to cancel the reserved rounds provided written notice of cancellation is furnished to the appropriate tournament coordinator no less than ninety (90) days in advance of the first day of play of the event. Cancellation results in Golf Club retaining the deposit. In addition, the Golf Club will be entitled to a cancellation fee as follows:

- Less than 90 days prior – 50% of the estimated subtotal
- Less than 60 days prior – 75% of the estimated subtotal
- Less than 30 days prior – 100% of the estimated subtotal

\*\*RAIN does not constitute cancellation of a golf event unless the golf course is determined to be closed by the course officials. The General Manager, Director of Golf, and/or Head Golf Professional are the only people authorized to officially close the golf course.

**Golf Club Weather Policy**

Should severe weather, frost, or other circumstance beyond the control of course management result in closure of the facility on or during the tournament group's scheduled day or days of play, the following procedure is agreed to:

- Nine holes or 2 ½ hours played by all participated constitutes a completed golf tournament.
- If the Golf Course General Manager or Head Golf Professional cancels the Tournament because of weather conditions before 9 holes are completed, the Tournament will be rescheduled.
- Closure of the facility is at the sole discretion of the Golf Club. The Golf Club reserves the right to restrict golf carts to cart path only due to inclement weather, overseeding, and/or any other condition at the sole discretion of the Golf Club.
